Basic Inward/Outward CIQP Clearance as a mandatory Service for Sea port Agent. Service covers all activities in compliance with the local regulations from pre-arrival to post-departure of the vessel.

Husbandry Services

Shipping Agency also manages the logistics and supply chain needs of the vessel, ensuring timely delivery of essential supplies and services. Key responsibilities include: Procuring and delivering ship supplies such as provisions, spare parts, and fuel (bunkering). Coordinating repairs and maintenance services. Arranging for waste disposal and environmental compliance services. Handling the logistics of spare parts and equipment.

Crew Change and Arrangement

IMIGRATION REGULATION



Immigration Law

- Law No. 6 of 2011 on Immigration, which serves as the primary legal framework for immigration management in Indonesia.
- Law No. 63 of 2024, which amends Law No. 6 of 2011, updating several provisions related to immigration policies.

Government Regulations

- Government Regulation No. 31 of 2013 on the implementation of the Immigration Law, which outlines visa procedures, residence permits, and immigration actions.
- Government Regulation No. 28 of 2019, which revises certain provisions of Government Regulation No. 31 of 2013, particularly regarding residence permits and immigration law enforcement.

Ministerial Regulations

- Minister of Law and Human Rights Regulation No. 22 of 2023 on Visas and Residence Permits, which regulates the process of issuing visas and residence permits for foreign nationals.
- Minister of Law and Human Rights Regulation No. 11 of 2024, an amendment to Regulation No. 22 of 2023, refining visa and residence permit policies.
- Minister of Law and Human Rights Regulation No. 27 of 2014 on Administrative Immigration Actions Against Foreign Nationals, which details administrative sanctions for immigration violations.

Directorate General of Immigration Regulations

- Directorate General of Immigration Decree No. IMI-0352.GR.01.13 of 2021, which regulates the issuance of visit visas and residence permits as part of immigration policy adaptation.
- Directorate General of Immigration Circular No. IMI-0701.GR.01.01 of 2023, which outlines the latest policies on residence permit extensions for foreign nationals.

ARRANGEMENT VISA AND RESIDENCE PERMIT SERVICES FOR SHIP CREW AND OWNERS

Immigration

Immigration Using Permit Arrangement for foreign Crew who wants to join the ship or arrange Business Visa for the Owner Representative:

- **Dahsuskim Permit (Stay Permit for Foreign Crew)**. We provide Stay Permit arrangements for foreign crew for up to 3 months or more. This applies to crew joining vessels operating in Indonesian waters or undergoing repairs in local shipyards. The permit is arranged before the vessel's arrival in Batam or Indonesian territory.
.....
- **Visa C1** - It is a Single-entry visa for tourism, family visits, meetings, conventions, or transit. Valid for an initial stay of up to 60 days. Extendable and convertible to a Limited Stay Permit (ITAS) with the same guarantor.
.....
- **Visa D1** - It is a multiple-entry visa for tourism, family visits, and participation in events or conventions. The visa is valid for 1, 2, or 5 years and allows a maximum stay of 60 days for each arrival. While this visa can be extended, it cannot be converted into a Limited Stay Permit. It is ideal for individuals who need flexibility and regular access to Indonesia without the need for new visa applications for each visit.
.....
- **Visa C2** - It is a single-entry business visa for meetings, purchases, inspections, and signing contracts. It also allows visiting friends or family. The initial 60-day stay can be extended and converted into a Limited Stay Permit with the same guarantor.
.....
- **Visa D2** - It is a Visa multiple entry for doing business, attending meetings, and making purchases of goods. You can also hold talks, discussions, negotiations, and/or sign business agreements. This type of Visa is a Visit for multiple entries to Indonesia with a maximum stay permit of 60 days per arrival with a Visa validity period of 1 Year, 2 Years and 5 Years, calculated from the date of arrival. This Stay Permit can be extended but cannot be converted into a Limited Stay Permit.
.....
- **Visa C13** - It is a Visa to join a means of transportation in the territory of Indonesia (join vessel). Including with this visa you can travel and visit friends and family with a first stay permit of a maximum of 60 days, calculated from the date of arrival. This Stay Permit can be extended and can be converted into a Limited Stay Permit with the same guarantor.
.....
- **Visa C17** - is a Single Entry Visa that grants an initial stay of up to 60 days for each arrival. This type of visa is intended for conducting audits, quality control of production, or inspections at a company's branch office in Indonesia. In addition, this visa also allows for tourism and visiting friends or family during your stay.
.....
- **Visa C20** - is a Single Entry Visa that allows for a one-time visit to Indonesia with an initial stay permit of up to 60 days for each arrival. This visa is intended for activities related to the installation and repair of machinery in Indonesia as part of a machinery purchase from abroad. In addition, this visa also permits tourism and visiting friends or family during the stay.

COMPANY LEGALITY DOCUMENT

● **SERTIFIKAT STANDARD / SIUPKK**

is a permit that must be owned by shipping agency entrepreneurs to carry out their business activities.

● **AKTA NOTARIS**

an official document made by a notary to record legal events. Notarial deeds are authentic and have strong evidentiary power.

● **NOMOR INDUK BERUSAHA (NIB)**

official address of a business entity. Business domicile is proven by a Business Domicile Certificate. is an official document issued by the local government.

● **IZIN OPERASIONAL BP BATAM**

The operational permit for ship agents issued by BP Batam is an official approval that allows the company to carry out activities as a ship agent in Batam waters.

● **NOMOR INDUK KEPABEANAN (NIK)**

is an identity number issued by the Directorate General of Customs and Excise to individuals, persons or business entities.

● **SK KEMENKUMHAM**

It is a document issued by the Ministry of Law and Human Rights (Kemenkumham) of the Republic of Indonesia as part of the company's legal status. This decree serves as official proof of legal entity approval, allowing the company to operate in compliance with the applicable regulations in Indonesia.

● **NPWP**

It is a tax identification issued by the Directorate General of Taxes (DJP) to businesses or companies operating in Indonesia. This NPWP serves as an identification number in tax administration and is a mandatory requirement for companies to conduct business activities legally.




